

International students must document their ability to meet all educational and living expenses for the first year of their intended study before this College can issue a Certificate of Visa Eligibility (form I-20) per immigration regulations. Although you must only show proof for the first year of study, **funding must be available for your entire course of study from your personal or sponsored funding sources.** International students are NOT eligible for financial aid and U.S. Federal immigration regulations severely restrict international student employment so students should not expect to subsidize their studies by earning income in the United States.

All documentation must be dated within one year of the date of initial enrollment at Le Moyne College. You must document financial support equal to or greater than this amount. Tuition and fee estimates, as well as cost of living expenses, will increase each academic year. Students must be prepared to meet these increases.
