

# STATEMENT OF STUDENT UNDERSTANDING

## Terms and Conditions

### 3+3 Le Moyne College Baccalaureate/

### University at Buffalo School of Law Juris Doctor Arrangement

#### *Overview*

The Pre-Law Committee at Le Moyne College (LMC) will serve as a selection committee that will interview and select potential students each year who may fit the established criteria for entry to the University at Buffalo School of Law (UB) after their junior year. Le Moyne College has no obligation to nominate a student or students to the University at Buffalo School of Law, even if the student fulfills the criteria.

Le Moyne students selected for participation by the LMC Pre-Law Committee will fulfill the established terms and conditions as well as fit the eligibility criteria set forth below. Once selected, participating students are expected to continue to meet all established terms, conditions and academic criteria.

Overall, participating students will complete all course requirements, with the exception of electives, for their major by the end of the junior year of undergraduate studies at Le Moyne College before entering the first year of law school at the University at Buffalo. Le Moyne students will receive their bachelor's degree upon successful completion of that first year of law school.

#### *Terms, Conditions and Eligibility Criteria*

##### **Conditional Admission:**

- During the second semester of Freshmen year, students from participating majors<sup>1</sup> will apply to the LMC Pre-law Committee at Le Moyne College for conditional admission into the Le Moyne College and University at Buffalo School of Law 3+3 Baccalaureate/Juris Doctor Arrangement.
- Participating students must maintain a GPA of 3.50 or higher.
- The names of students selected by the Pre-Law Committee at Le Moyne College will be forwarded to the University at Buffalo School of Law Vice Dean for Admissions. Le Moyne College's Pre-law Advisor, in conjunction with the Department Chair of the student's respective major at Le Moyne College, will then serve as principal advisors to these students during their undergraduate years.
- Participating students will be provided a typical program that shows the curricular path for the LMC/UB 3+3 Arrangement for their respective major.
- Participating students will complete all course requirements, with the exception of designated

electives, for their respective major by the end of the junior year.

- Le Moyne College will award a baccalaureate degree to participating students who enroll at the School of Law through this arrangement and who successfully complete the first year of law school.

### **Final Admission:**

- Le Moyne students will be eligible to apply as a 3+3 candidate to the Law School only if s/he will have completed all course requirements, with the exception of electives, for their major by the end of the junior year. The remaining elective courses will be used to fulfill the requirements for the baccalaureate degree, which in this case will be met by completion of the first year of law school. Once the student applies to the Law School through the 3+3 option, the Pre-Law Director at Le Moyne College will send to the student, a copy of the 3+3 Combination Baccalaureate/Juris Doctor Certification Statement (sample below). It will be the student's responsibility to have this certification statement signed by the Registrar at Le Moyne College and returned to the University at Buffalo School of Law to complete the application process as a 3+3 candidate. A copy of the certification statement should also be provided to the Pre-Law Director at Le Moyne College.
- The application fee will be waived for any Le Moyne College student who applies through this LMC/UB 3 + 3 Arrangement.
- Students will apply as first year J.D. candidates.
- The University at Buffalo School of Law will grant admission to students recommended by the Le Moyne College Pre-Law Committee who seek early admission to the Law School through this 3+3 Agreement and meet the requirements set forth below:
  1. Le Moyne students must complete the LSAT or GRE no later than January of their junior year and must apply to University of Buffalo School of Law no later than February 1 of their junior year of undergraduate studies. Students should take the LSAT or the GRE, but not both. If the students submit both LSAT and GRE scores to the School of Law, the LSAT score will be used to determine their candidacy for progression to the School of Law. An LSAT score at or above the median LSAT for the Law School's previous year's enrolled class or a GRE score at or above the 70<sup>th</sup> percentile on Verbal Reasoning and 40<sup>th</sup> percentile on Quantitative Reasoning will be required.
  2. Le Moyne students must have a cumulative undergraduate grade point average of at least 3.50 as of the end of their third year of undergraduate study.
  3. Le Moyne College students must complete a standard application to the University at Buffalo School of Law through the LSAC. Applications must include two letters of academic recommendation from a Le Moyne faculty member or the Le Moyne College Pre-Law Committee.
- Once enrolled in the University at Buffalo School of Law, Le Moyne students must adhere to, and their continued enrollment will be subject to, the policies, procedures, rules, and regulations of the Law School, including but not limited to its academic standing requirements for first year law students.

- An official, final transcript must be sent to University at Buffalo School of Law showing that a baccalaureate degree was conferred at the end of the student’s first year of law school.

**University at Buffalo School of Law Tuition and Merit Scholarships:**

- Tuition while attending the University at Buffalo School of Law will be charged at its rate. Le Moyne students will be eligible to apply for scholarships and financial aid available through the Law School.
- Students will not be eligible for undergraduate level federal, state, or institutional aid from Le Moyne College (e.g., Pell, TAP, and Le Moyne scholarships) while attending the University at Buffalo School of Law.

**Student Acknowledgment**

I have received and reviewed the above *Statement of Student Understanding* regarding the LMC/UB 3+3 Baccalaureate/Juris Doctor Arrangement in a meeting with the Pre-Law Director at Le Moyne College. I also understand that either or both Le Moyne College and the University at Buffalo School of Law may change the terms, conditions and eligibility criteria over time. In that event, the Pre-Law Director will provide updates to participating students.
